

## Jacque's Trauma Response

(What the BPD used-targeted to discredit Jacque)

- 6-7 y.o. sexual abuse by members of clergy w/in Catholic church. A settlement has been paid to Jacque.
- Up to 17 y.o. Mom was later discovered to be a potential murderer—3 men all found dead in shower.
- Her response after murder—shutting down and retreating, viewed as abnormal behavior by others.
- Sexual encounter with Chris after murder—survival response.
- Extreme paranoia.
- Keeping him at house—how she wanted to protect others from him while trying to gather evidence. No one is listening to her during this time.

## Profile

Chris Wolf

- Denial of knowing about Access Graphics
  - Date book has info written in 1995 about interviewing someone from company
  - Wrote an article about Access Graphics
- 3 weeks prior (Nov 30<sup>th</sup>) threatened to strangle Walt Kinderman (former boss)
  - Threat was a response to being fired
  - Walt's wife, Patty P., witnessed this event
- Frequent mentions of strangulation of people (including to Jacque)
- Interest in women and children of 3<sup>rd</sup> world countries (claiming wanting to volunteer to assist them)
- Claimed to be homosexual—No evidence of this in his behaviors other than what he said in deposition
- Mentioning going to a place in Denver where he could “do anything with anyone,” and asking Jacque to accompany him
- Continual blame of Ramsey's
  - Fixation on this lessens responsibility and shows narcissism traits of how he justified the murder
- OCD Tendencies
  - Constantly preoccupied mentally
  - Obsessive perfectionism with symmetry in chairs
  - Garrote perfectly centered on throat of victim
- McKinley Letter—each paragraph tells a story in
  - Personality
  - Motive
  - Justification
- Bx in disposition
- Male stripper
  - Solicitation
  - Indecent exposure (masturbation in public)

- Inability to hold down a job—fired from every job
- Stalking Jacque—ongoing until 1999
- Leaves box with Jacque containing
  - JonBenet Ramsey articles & photos
  - Susanna Chase articles & photos
  - Carol McKinley letterHe retrieves box later
- Extreme outbursts
- Paranoia

That's the man I saw entering the Ramsey's house!"<br/>-Glenn Meyer used to live across the street from Ramsey's<br/>-Jacque witness<br/>-Chris didn't even react to this at all</li> <li>■ Beaver (or Capybara) hat that he wore all the time from November through December of 1996, that was never seen again after the murder</li> <li>■ Very soft rope (like that found on the body) found in package on Chris's desk by Jacque on Dec 20, 1996</li> </ul> | <ul style="list-style-type: none"> <li>■ Animal fur found at murder scene consistent with color/hair of Chris's hat brought back from Mexico</li> <li>■ Was ink tested on JonBenet's hand? Could be the same that was used on article with 'heart' on John's name</li> <li>■ Blue and black fibers found on body—were they tested/compared to black leather jacket?</li> <li>■ Doorknob @ Dakota vs. doorknob @ Ramsey's—have pictures been compared?</li> <li>■ Army bag found in crawl space and Jacque finding same bags in Chris's possession</li> <li>■ Handwriting comparison from Ransom note &amp; Chris's writings</li> <li>■ Jacque has a piece of rope like that she found on Chris's desk—can we compare it to the rope that was collected under spare bed in Ramsey's spare bedroom?</li> </ul> | <ul style="list-style-type: none"> <li>■ Wanting computer articles deleted—trying to hide things—is this a pattern?</li> <li>■ Statement in 'The Globe' where he calls 'fascist police state'—shows grudge/disdain</li> <li>■ Responses during deposition—shows behavior</li> <li>■ 'OJ and I get away with everything'</li> <li>■ Statement made in Carol McKinley letter—overly emotional</li> <li>■ Denies knowing anything about Access Graphics—denial pattern of behavior</li> <li>■ Switches physical car he is driving on Dec 26, 1996, to Jacque's truck—showing returning (potential) to crime scene and discreetness of concealing identity</li> <li>■ Dec 26, 1996, Jacque is woken up by him entering room in dirty clothes &amp; he tells her he has 2 days left before they need washing (5:30 a.m.). Then at 1:00</li> </ul> |

- Santa Barbara shirt received by Chris on Dec 25, 1996
- Truck seen by John Ramsey—ransom note indicated they would be watching
- Newspaper that was placed on Ramsey's desk with red marking around John's name and Chris's article on adjacent page
- Blue sweatshirt & black leather jacket that he always wore
- Dirt line across shirt under chest and across pant knees when Jacque saw him before heading into the shower at 5:30 a.m. Dec 26, 1996 (Jacque woke to him getting into shower, and this was an unusual time for him to do so.)
- Baseball bat missing from Jacque's—Baseball bat found at crime scene
- Journal & Daytimer in BPD possession
- Police report from detaining Chris in

- Chris asking Jacque if Santa Barbara t-shirt was a tennis club shirt
- Uses Jacque's truck on Dec 26, 1996, after claiming his car wasn't working, even though it had been driven earlier -This truck was also seen by John Ramsey Dec 26, 1996 (even noted in John's book)
- Line of dirt across shirt (under chest) and pants (across knees) as seen by Jacque
- Patty & Walt reporting him smelling all the time from wearing the same clothing
- Missing baseball bat
- Chris's behavior after murder and days following as evidenced by Jacque along with what she had read in his journals
- Meets with Pastor of Ramsey's church with concerns and asked if there was political motives or agenda in the ransom note (before such motives were released to the press) -This prompted them to

p.m. he asks her to wash them.

- 'Mr. Murder,' Jacque's transcript & 'In Cold Blood'—found that Chris read around this time. He would also hang out in a murder bookstore
- Dec 26, 1996—watching 5 p.m. news and he becomes visibly anxious, agitated & manic and continues this behavior for 5 days after
- Jacque read in his journal concerning entries about celebrating Hitler & dressing in drag
- After strangling Jacque he had similar behaviors/response as compared to days following murder
- Stopped by police in Jan 1997—Chris became combative, denied DNA & handwriting samples, and was hobbled by 6 police officers due to his aggressive and agitated behavior. Told Jacque he'd kill himself *when* the police come for him
- Ongoing lying behaviors as evidenced by deposition

| <p>1997—became so violent he required hobbling</p> <ul style="list-style-type: none"> <li>■ Doorknob markings of forced entry at Jacque’s were similar to markings found on Ramsey house</li> <li>■ Little girl’s underwear found in Jacque’s laundry room and entry to the property—shows preference of deviant sexual behavior</li> <li>■ Knot tying experience from outbound program</li> <li>■ Affidavit from Charles Sangston letter</li> <li>■ Army bag brought to Jacque’s when Chris moved back was similar to the one later found at Ramsey’s</li> <li>■ Marking on JonBenet’s hand could be ‘signature’ of Chris’s initials</li> <li>■ Jacque brought in rope to BPD that was missing about 6’ length before it had been released to the public that rope was used as part of the murder.</li> </ul> | <p>bring in the church attorney to speak with Jacque (1997)</p> <ul style="list-style-type: none"> <li>■ Forced entry marks at Jacque’s (when Chris was learning to “break-in”) were similar to those found at the Ramsey house</li> <li>■ Chris yelling at Jacque that “you think I killed her, don’t you?!” in Marah’s presence—Feb 13, 1997</li> <li>■ Deviant and bizarre sexual behaviors</li> <li>■ Threatens to strangle Walt when he is fired by him</li> <li>■ Tells Jacque that he would never use his bare hands to strangle someone</li> <li>■ Tells Jacque that he and “OJ get away with everything” Dec 27, 1997</li> <li>■ Barbara Harvey witnesses him going ballistic when she mentions John Ramsey article (started ranting about John Ramsey killing women and children in 3<sup>rd</sup> world countries)</li> <li>■ Charles Sangston notarized letter</li> </ul> |  | <p>and other evidence, as well as telling Jacque he is a compulsive liar and would take his own life before ever going to jail</p> <ul style="list-style-type: none"> <li>■ Focusing/fixation on Ramsey’s even when pulled over</li> <li>■ Asking Jacque about if she thought he was the killer during the Alex Hunter press release</li> <li>■ Deviant sexual behavior <ul style="list-style-type: none"> <li>-Phone calls</li> <li>-Children’s underwear</li> <li>-Venue he would go to, to act out on these behaviors</li> <li>-Indecent exposure</li> <li>-History of stripping</li> <li>-Selling self for sex in ad in sex magazine</li> </ul> </li> <li>■ Nov 30, 1996—threatens to strangle Walt Kinderman after he is fired by Walt</li> <li>■ Dec 27, 1996—tells Jacque that he would never strangle someone with his bare hands</li> <li>■ Knot tying &amp; outward bound experience</li> <li>■ Charles Sangston writes letter about when Chris said ‘wouldn’t it be great to grab</li> </ul> |

- Jacque noticed that the cuff of sweater is torn on Chris's blue sweater on Dec 26, 1996  
-Fits Lou's testimony that window was broken in (Pg. 210 of Lou Smit deposition)
- Jacque had missing flashlight  
-Asked BPD about this before flashlight was made public  
-Flashlight found on counter at crime scene

- Owned an army bag similar to one found at crime scene
- Asked Marah's BF to show him how to break into a house
- Oct 1996—Stating to Marah and Jacque that he had seen Patty and JonBenet at Lever's Grocery
- Changes parking routine and exhibits other odd and extreme behaviors around the time of the murder
- Hatred for high society, money, tennis clubs, etc.
- Rant on the morning of Dec 26, 1996 to Jacque about the MF on the hill
- Jacque knowing/bringing forth rope to authorities before release of murder weapon
- Friend 'Mike' who lived in Niwot—could this be Michael Helgroth?
- Jacque to attest to his avid love of climbing and likelihood of rope found under bed @ Ramsey's
- Jacque's missing flashlight

a little girl, tie her up and do whatever you want with her'

- Asking to be shown how to break into a house
- Oct 1996—excitement over seeing JonBenet and Patsy Ramsey in Lever's Grocery store
- Begins changing where he parks at Jacque's home
- Hatred for high society, money, tennis clubs, etc.
- Bizarre behavior on Christmas day  
-Says he is going to a company party on Christmas Day  
-Behavior and mood very odd when he comes home  
-Says he's not hungry and then shortly after growls angrily at Jacque that he's starved
- Dec 26, 1996 @ 9:00 a.m. he returns home and is having a bizarre, manic rant about the "Motherfucker on the hill"
