00008 MS. DILSON CAME TO THE LYONS SUBSTATION, REQUESTING TO SPEAK
00009 WITH A DEPUTY. I MET WITH MS. DILSON AND SHE TOLD ME SHE
00010 LIVES AT 11510 N. FOOTHILLS HWY. IN BOULDER COUNTY, COLORADO.
00011 SHE STATED ON 051199, SOME TIME BETWEEN THE HOURS OF 2100 AND
00012 2200, HER PHONE WENT OUT. SHE TOLD ME SHE NARROWED THE TIME
00013 DOWN BECAUSE SHE RECEIVED MESSAGES ON HER ANSWERING MACHINE
00014 JUST PRIOR TO THEN.

00016 MS. DILSON WAS VERY UPSET AND WAS SPEAKING VERY RAPIDLY. SHE
00017 TOLD ME SHE FELT IT WAS SO BIG, SHE NEEDED TO GO STRAIGHT TO
00018 GEORGE EPP, ALEX HUNTER, AND THE MAN IN CHARGE OF THE GRAND
00019 JURY FOR THE JON BENE RAMSEY CASE.

00021 I ASKED HER TO EXPLAIN TO ME WHAT WAS GOING ON, AND SHE STATED
00022 IT WAS VERY CONFIDENTIAL AND SHE SHOULD NOT BE SPEAKING TO ME
00023 ABOUT IT, BUT SHE BELIEVED HER BOYFRIEND HAD KILLED JON BENE
00024 RAMSEY. MS. DILSON TOLD ME THIS INFORMATION HAD BEEN DOCUMENTED
00025 BY SGT. MCGRATH.

00027 MS. DILSON TOLD ME SHE WAS "WORKING VERY, VERY, VERY CLOSELY
00028 WITH THE JON BENE CASE." MS. DILSON TOLD ME SHE BELIEVED
00029 HER EX-BOYFRIEND WAS RESPONSIBLE FOR TAMPERING WITH HER

00032 MS. DILSON TOLD ME ORIGINALLY THE PHONE COMPANY HAD TOLD HER
00033 IT WAS A PROBLEM WITH THE OUTSIDE LINE, AND THEN SHE LEARNED
00034 ON 051599, THE PROBLEM WAS FROM WITHIN HER PHONE UTILITY BOX
00035 LOCATED OUTSIDE OF HER HOME. MS. DILSON TOLD ME "LARRY"
00036 FROM US WEST HAD BEEN TO HER HOUSE THIS AFTERNOON AND
00037 TOLD HER HE COULD NOT GUARENTEE TO HER NO ONE HAD
00038 TAMPERED WITH THE WIRES. MS. DILSON DID NOT KNOW LARRY'S LAST
00039 NAME, BUT I DID CONTACT US WEST, AND ASKED THEM TO HAVE
00040 THE WORKER WHO HAD WORKED ON HER LINE TODAY TO PHONE ME.
00041 I NEVER HEARD BACK.

00043 MS. DILSON TOLD ME SHE HAD NOT TOLD US WEST THIS, BECAUSE
00044 SHE DID NOT WANT THEM TO KNOW, BUT IN THE PAST WHEN SHE
00045 HAD PROBLEMS WITH HER PHONE, SHE HAD GONE OUT AND "MESSED"
00046 WITH THE WIRES HERSELF.

00048 MS. DILSON CONTINUED TO BE VERY ANIMATELY AND SPEAK VERY QUICKLY,
00049 JUMPING FROM INCIDENT TO INCIDENT REFERENCE HER BELIEFS ON THE
00050 JON BENE RAMSEY CASE. SHE KEPT SAYING SHE DID NOT KNOW WHAT
00051 WE WERE GOING TO DO AND HOW WE WERE GOING TO HANDLE THIS.
00052 I ASKED MS. DILSON EXACTLY WHAT SHE WANTED TO HAPPEN SO I
00053 COULD UNDERSTAND AND APPEASE HER.

00055 MS. DILSON JUST CONTINUED TO SAY SHE HAD TO GET IN TOUCH
00056 WITH GEORGE EPP, AND ALEX HUNTER. I EXPLAINED TO MS. DILSON
00057 I WOULD DOCUMENT THIS UNDER THIS CASE NUMBER, AND PROVIDED HER
00058 WITH THE CASE NUMBER ON A BUSINESS CARD. I ALSO TOLD HER I
00059 WOULD HAVE MY SUPERVISOR CALL HER SO THEY COULD RESOLVE
00060 WHAT THE NEXT STEP WOULD BE.

00062 I CONTACTED SGT. DUNPHY AND RELAYED THE INFORMATION TO HIM AND
00063 REQUESTED HE SPEAK WITH HER. I ALSO PROVIDED HIM WITH THE
