00001 {SYNOPSIS} THE FOLLOWING REPORT WILL DETAIL AN INCIDENT, OFFICER
00002 INFORMATION, CONCERNING A WELFARE CHECK OF A PARANOID INDIVIDUAL.

00004 {DESCRIPTION} ON 092697, AT APPROXIMATELY 0850 HOURS, MYSELF, ALONG
00005 WITH OFFICER UNOCIC, #571, AND OFFICER ARMSTRONG, #565, RESPONDED
00006 TO 11510 NORTH FOOTHILLS HIGHWAY ON THE REPORT OF A DELUSIONAL AND

00007 PARANOID INDIVIDUAL. PRIOR TO THIS CALL, I SPOKE WITH OFFICER KYLE
00008 MILLER, #575, WHO HAD CONTACTED THE COMPLAINANT BY TELEPHONE. THE
00009 COMPLAINANT, IDENTIFIED AS DEBBIE ELLIOTT, STATED HER FRIEND, JACKIE

00010 DILSON, DOB: 070548, HAD SPOKEN WITH HER ON 092597, AT 2100 HOURS.

00011 THE COMPLAINANT ADVISED JACKIE WAS VERY DELUSIONAL AND PARANOID
00012 STATING HER EX-BOYFRIEND HAD KILLED JON BENET RAMSEY. AS A RESULT,
00013 THE SUSPECT, JACKIE DILSON, IS CURRENTLY CARRYING WITH HER A LOADED
00014 .357 MAGNUM REVOLVER. THE COMPLAINANT STATED SHE OFFERED HER HOME
00015 SO THAT JACKIE COULD STAY THERE AND FEEL MORE COMFORTABLE. THE
00016 COMPLAINANT STATES SHE FEELS JACKIE NEEDS MENTAL TREATMENT FOR HER
00017 PROBLEMS AND IS AWARE JACKIE IS CURRENTLY BEING ATTENDED BY A DOCTOR
00018 IN BOULDER. THE COMPLAINANT WAS UNABLE TO FURNISH ME WITH ANY
00019 INFORMATION CONCERNING THE DOCTOR.

00021 ON 092697, AT APPROXIMATELY 0900 HOURS, MYSELF AND DEPUTIES ARMSTRONG
00022 AND UNOCIC, WENT TO THE RESIDENCE. UPON OUR ARRIVAL, WE WERE CONFRONTED
00023 OUTSIDE THE RESIDENCE BY MARIA DILSON, THE DAUGHTER OF THE SUSPECT.
00024 MARIA STATED HER MOTHER WAS NOT HOME AND WAS CURRENTLY WITH HER
00025 HUSBAND IN NORTHGLENN, COLORADO, WHERE SHE WAS ASSISTING HIM WITH
00026 RETRIEVING A VEHICLE WHICH WAS BEING REPAIRED. I ASKED MARIA IF
00027 SHE HAD NOTICED ANYTHING UNUSUAL ABOUT HER MOTHER. SHE STATED SHE
00028 FEELS HER MOTHER IS VERY PARANOID AND I DESCRIBED THE COMPLAINT I
00029 HAD RECEIVED. MARIA THOUGHT THIS WAS CONSISTANT WITH HER OBSERVATIONS.
00030 I ASKED MARIA IF HER MOTHER HAD A WEAPON. MARIA STATED THE WEAPON
00031 WAS CURRENTLY AT THE RESIDENCE AND MARIA ALLOWED ME TO TAKE THE WEAPON
00032 INTO CUSTODY FOR SAFEKEEPING. AT THIS TIME I RETRIEVED A RUGAR .357
00033 REVOLVER, SERIAL NUMBER 150-23736, WHICH WAS TAKEN INTO CUSTODY AND
00034 PLACED INTO EVIDENCE FOR SAFEKEEPING. I GAVE MARIA A RECEIPT FOR THE
00035 WEAPON. MARIA ALSO FURNISHED ME WITH THE TELEPHONE NUMBER FOR JACKIE'S
00036 PHYSICIAN, IDENTIFIED AS DR. PHILLIPS, PHONE NUMBER 449-3594.

00038 ON THIS DATE, I SPOKE WITH DR. BROWN, ANOTHER PHYSICIAN WORKING IN
00039 DR. PHILLIPS OFFICE. DR. BROWN ADVISED ME DR. PHILLIPS WAS CURRENTLY
00040 NOT AVAILABLE, BUT SHE WAS FAMILIAR WITH THE CASE. SHE INFORMED ME
00041 JACKIE HAD COME TO THE OFFICE TO OBTAIN PRESCRIPTION MEDICATION ON
00042 TODAY'S DATE AND LEFT VERY ANGRY. I ADVISED DR. BROWN OF THE SITUATION
00043 AND ASKED THAT SHE CONTACT THE BOULDER POLICE DEPARTMENT IN THE
00044 EVENT THAT JACKIE WERE TO RETURN SO OFFICERS AND DOCTORS COULD DO
00045 A 72-HOUR EVALUATION. DR. BROWN WAS ADVISED TO CONTACT ME IN THE
00046 EVENT THEY HEAR FROM JACKIE IN THE FUTURE.

00048 ON THIS DATE, I CONTACTED BOULDER COUNTY SHERIFF'S DEPARTMENT RECORDS
00049 AND HAD THEM DO A TELETYPE TO NORTHGLENN POLICE DEPARTMENT AS WELL
00050 AS THE NORTH METRO AREA. I REQUESTED THEY ATTEMPT TO LOCATE JACKIE
00051 AFTER I OBTAINED A VEHICLE LICENSE PLATE FROM COSIN. A TELETYPE WAS
00052 SENT ON THIS DATE.

00054 IT WAS LEARNED THE SUSPECT MAYBE VISITING MARIA DILSON ON 092697,
00055 APPROXIMATELY BETWEEN 12:00, NOON, AND 1300 HOURS, IN LYONS, COLORADO,
00056 AT THE SODA FOUNTAIN ON MAIN STREET. MARIA STATED SHE WOULD CONTACT
00057 THE SHERIFF'S DEPARTMENT WHEN JACKIE RETURNS. I ALSO INSTRUCTED
00058 MARIA TO ADVISE JACKIE THE WEAPON WAS TAKEN INTO CUSTODY AND HAVE
00059 HER CONTACT ME SO I COULD DISCUSS WITH HER IF THE WEAPON COULD BE
00060 RETURNED.

00062 WHEN THE WEAPON WAS PLACED INTO SAFEKEEPING, I SPOKE WITH EVIDENCE
00063 TECHNICIAN CAVALIER. SHE ADVISED ME SHE BELIEVES THIS IS THE SAME
00064 WEAPON WHICH HAD BEEN KEPT FOR SAFEKEEPING IN 1995 INVOLVING THE SAME
00065 PARTY. CAVALIER FELT THAT DUE TO THE FREQUENCY OF INCIDENTS A LETTER
00066 WOULD BE NEEDED FROM THE DOCTOR IN ORDER FOR THE WEAPON TO BE RELEASED.
00067 I AGREED TO THIS AND SIGNED THE EVIDENCE SHEET REQUESTING A DOCTOR'S

00068 LETTER BE INCLUDED PRIOR TO THE WEAPON BEING RELEASED.
