00004 SHE KNOWS THE SUSPECT WOULD NOT GIVE INFORMATION. IT IS POSSIBLE THE
00005 VICTIM IN THIS CASE IS SUFFERING FROM PARANOIA, SEE CASE NUMBER
00006 S97-15395. RECOMMENDED CASE STATUS WILL BE OPEN.

00008 {DESCRIPTION} ON 100797 JACKIE DILSON, DOB: 070548, CAME TO THE
00009 LYONS TOWN HALL AND ASKED FOR SGT. TOM MCGRATH. WHEN I TOLD HER
00010 SGT. MCGRATH WAS ON VACATION SHE STATED SHE WANTED TO SPEAK WITH
00011 HIM ABOUT AN INCIDENT. I ASKED HER IF I COULD HELP HER IN REFERENCE
00012 TO THE INCIDENT. SHE STATED, "TOM KNOWS EVERYTHING" AND SHE HAD
00013 BEEN WORKING WITH HIM FOR APPROXIMATELY EIGHT MONTHS ON THE SITUATION.
00014 I EXPLAINED TO HER I WAS UNSURE AS TO WHEN SGT. MCGRATH WOULD BE
00015 BACK FROM VACATION AND ASKED HER IF SHE WISHED TO FILE A REPORT ON
00016 THE "INCIDENT." SHE TOOK SEVERAL MINUTES TO TALK WITH HER COMPANION
00017 AND THEN DECIDED TO TELL ME.

00019 MS. DILSON EXPLAINED SHE LIVES AT 11510 NORTH FOOTHILLS AND HAS
00020 BEEN HAVING SEVERAL STRANGE INCIDENTS OCCUR AT HER HOME. SHE
00021 STATED HER PHONE GETS CHANGED BY PEOPLE CHANGING THE PHONE WIRES ON
00022 HER PHONE BOX TO DIFFERENT TERMINALS. SHE FURTHER EXPLAINED THAT
00023 ON THE PREVIOUS EVENING, 100697, SOMETIME BETWEEN 11:00 IN THE MORNING
00024 AND 7:00 AT NIGHT, SOMEONE HAD GONE INTO THE POOL AREA OF HER HOME AND
00025 TURNED THE POOL ON. SHE EXPLAINED A DEADBOLT LOCK IS ON THE REAR
00026 DOOR AND WHEN SHE RETURNED HOME AT APPROXIMATELY 7:00 P.M., THE LOCK
00027 WAS UNLOCKED. AS SHE DROVE UP TO THE HOUSE, SHE NOTICED THE WINDOWS
00028 AROUND THE POOL AREA WERE FOGGED UP. SHE EXPLAINED THIS USUALLY
00029 ISN'T THE CASE AS SHE KEEPS THE POOL TURNED OFF. AS SHE WENT INTO
00030 THE DOOR TO THE POOL AREA, SHE NOTICED THE DIAL FOR THE POOL HAD

00040 PHONES BEING CHANGED, HAD BEEN DOCUMENTED. SHE EXPLAINED NONE OF
00041 THE OTHERS HAD BEEN DOCUMENTED IN REPORTS.

00043 I LOOKED UP MS. DILSON'S NAME IN THE COMPUTER, AT HER REQUEST, TO
00044 SEE IF ANY OTHER REPORTS HAD BEEN DONE. I FOUND ONE OTHER REPOR,
00045 CASE NUMBER S7-15395, DONE BY DEPUTY FERGUSON. THIS REPORT IS AN
00046 OFFICER INFORMATION REPORT DEALING WITH HIS CONTACT WITH MS. DILSON.
00047 THE REPORT TALKS ABOUT HOW MS. DILSON IS POSSIBLY PARANOID.

00049 I ASKED MS. DILSON IF ANYTHING ELSE IN THE HOUSE WAS TOUCHED, MOVED,
00050 OR TAKEN. SHE STATED, NO, THE ONLY THINGS TOUCHED WERE THE LOCK
00051 AND THE DIAL TO THE POOL. SHE EXPLAINED THE LOCK HAD NOT BEEN
00052 BROKEN, BUT WHOEVER HAD COME IN HAD COME IN USING A KEY. THAT IS WHY
00053 SHE POSSIBLY KNOWS WHO THE INDIVIDUAL IS. I AGAIN ASKED HER TO TELL
